
- Obtain and learn the 2009 TNI Standard

  - NELAP AC Program Administrator or TNI Executive Director


### How to Become an AB

- Evaluation Team will be formed after application received
- No fee required with application, but applicant does pay travel expenses for evaluators' on-site visit
- Expect about 9 months to elapse between application and completion of evaluation (per SOP)


Application Process Flowchart
